Executive Summary

Infinity Robot Token (IFNTBT) is a utility token designed to power an Al-assisted trading ecosystem that emphasizes discipline, risk management, and community governance. IFNTBT aligns incentives between the protocol, developers, and holders through deflationary mechanics, staking utilities, and transparent tokenomics.

Problem & Opportunity

Retail traders face emotional biases, inconsistent signals, and fragmented tooling. Markets run 24/7; human traders can't. There is a need for automated, trustworthy systems that translate high-quality data into disciplined execution.

Solution & Architecture

IFNTBT provides a modular stack: signal generation (AI models), risk management layers (position sizing, stop rules), and optional execution modules that users can opt into. The stack is accessible via subscription paid in IFNTBT or via staking tiers.


Key modules: Signals, Risk, Automation, Telemetry (analytics).


